\$2,500 bond pending arraignment January 7.

Misdemeanor arrests included charges against a Weems man, 21, on December 18 for domestic assault. He was held in jail under a \$500 bond pending arraignment.

A Lancaster woman, 19, was arrested for assault and battery on Christmas Day. She was released on a personal recognizance bond pending arraignment.

A Wicomico Church woman, 33, was charged with trespassing and was released on a summons.

A Lancaster man, 23, was charged with a bad check and was released on a summons.

A Wicomico Church man, 31, was arrested for failing to appear in court in connection with a trespassing charge. He was released on a \$250 bond pending arraignment.

On December 21, two juveniles admitted to recently damaging several mailboxes in the Ottoman area. Petitions are expected to be filed in at least four cases this week.

A Springdale Road property owner reported a burglary and theft of approximately \$1,000 in property on December 21. A 19-inch color television, a microwave oven, a Nintendo system with 20 games and six fishing rods were reported stolen. The case remains under investigation.

Damages were reported December 27 to the Merry Point post office. The plate glass window in the lobby was apparently shot at with a BB gun.

On December 28, an Oldhams resident driving near the Virginia Department of Transportation area office reported that his car was struck with a shotgun slug. The round destroyed the windshield to the car but did not injure the occupants. A hunter in the immediate area is believed to have been responsible.

On December 29, Martin Ward of Lancaster Shores reported the theft of his 1985 Buick sometime after 9 p.m. on December 28. The theft was reported after the car was discovered burning at about 3 a.m. in the Lancaster Shores area. The case remains under investigation.

The same night a White Stone convenience store clerk reported the theft of a boom box stereo from his pickup truck. Suspects in the case are described as two white males, accompanied by a pregnant white female; all were in a rust colored GMC pickup truck.

**Northumberland County Sheriff Wayne J. Middleton** also had four felonies to report this week.

On December 17, Christopher R. Orifice, 31, of Richmond was charged with assaulting and abducting a Callao female.

On December 24, Stanley T. Brown, 29, of Warsaw was arrested for threatening an illegal or immoral act with intent to intimidate a female.

On Christmas Eve a Callao man, 36, was charged with appearing drunk in public, and another Callao man, 32, was arrested for brandishing a firearm.

On December 26, a Callao man, 32, was charged with failing to appear in juvenile and domestic relations court December 20.

A Heathsville man, 45, was charged December 26 with assault and battery on a female.

**Westmoreland County Sheriff C.W. Jackson** reported the arrest December 24 of Ricky Wayne Campbell, 30, of Colonial Beach following the shooting death of a six-year-old girl, Candice M. Turner, while she was sleeping in her bed.

The child was shot when a domestic argument between the child's grandmother and Campbell erupted into gunfire; the house was sprayed with what officers referred to as "a Chinese-made assault rifle or an AK-47 clone."

A magazine for that type of weapon carries about 30 rounds of ammunition.

Westmoreland Sheriff's Lt. Roy Sydnor reported Campbell has been charged with murder in the death of the child; shooting into an occupied

dwelling; use of a firearm in the commission of a felony; and three cases of attempted murder for shooting at his girlfriend, 48 (the child's grandmother), her daughter, 24, and her husband, who also lived in the house. The woman's son, 20, also lived in the four-room house at Placid Bay Estates, which is located about midway between Oak Grove and Colonial Beach, as well as Campbell.

Candice Turner was the 24-year-old's child, according to Sydnor; a seven-month old sister of Candice also was asleep in the same room at the time. A bullet penetrated the window above the crib where that child was sleeping, he said, and struck the top of the bunk bed. Candice was sleeping in the lower bunk when she was hit in the head by a bullet.

Sydnor said eight bullet holes were found in the house, and one was an exit hole for a bullet that penetrated through the entire house. Neighbors reported hearing about 18 to 20 shots being fired after the argument had been going on for about 30 minutes.

The child's father had run to a neighbor's home to get them to call the police, Sydnor said, after the argument escalated and the gun came into view. No other weapons were found inside the house, he added.

"We're still putting together bits and pieces of why the argument started, and why it escalated into violence," he said. "The child was sleeping in a front room to the right of the house and the couple were standing outside on the left of the house while they argued." The argument apparently began as Campbell and the grandmother returned to the house, and Campbell shot at the woman as she left his pickup truck. The others in the household became involved as they tried to break up the argument. Sydnor noted that alcohol was involved.

Campbell was arrested shortly after the approximately 2:30 a.m. shooting on Tuesday. A deputy found Campbell sitting in his vehicle a short distance from the house.

"Luckily, nobody else was hurt," said Sheriff Jackson. "He sprayed the front of the house with bullets."

Sydnor said the incident was the first slaying recorded in Westmoreland in 1996. In 1995 the county recorded two slayings. He noted that domestic arguments have caused injuries to innocent children in the past, "but nothing of this magnitude." Holiday periods sometimes bring

out the worst in couples, he added, and deputies and state police expect to see an increase in domestic assault cases. The county had several other domestic assault cases over the holiday period, "but nothing with weapons," he said. "Again, they were nothing of this magnitude."

The sheriff also reported a break-in December 27 and the larceny of guns from a home in the Coles Point area. The same day a bicycle was stolen from a Kinsale home.

Colonial Beach police are looking for two men who robbed the

Subway sandwich shop on Christmas Eve.

Two men entered the store at the Beachgate Shopping Center at about 5:30 p.m. One left and got into a gray car, according to Sgt. Joseph Head. The other jumped the counter, threatened the clerk and emptied the cash register. He also took money from the clerk's wallet.

He then ran out of the store and entered the gray car described as either a Toyota or a Dodge Colt with a loud exhaust system. The robbery remains under investigation.
